# **Privacy Policy**

Protecting your private information is our priority. This Statement of Privacy applies to www.SimplyMaidOK.com, and Simply OK Maid LLC and governs data collection and usage. # **Collection of your Personal Information**

In order to better provide you with products and services offered, Simply Maid OK may collect personally identifiable information, such as your:

- First and Last Name

If you purchase Simply Maid OK's products and services, we collect billing and credit card information. This information is used to complete the purchase transaction.

# **Use of your Personal Information**

# **Sharing Information with Third Parties**

- Comply with the California Electronic Communications Privacy Act;
- Engage in public or peer-reviewed scientific, historical, or statistical research in the public interest that adheres to all other applicable ethics and privacy laws, when our deletion of the information is likely to render impossible or seriously impair the achievement of such research, provided we have obtained your informed consent;
- Enable solely internal uses that are reasonably aligned with your expectations based on your relationship with us;
- Comply with an existing legal obligation; or
- Otherwise use your personal information, internally, in a lawful manner that is compatible with the context in which you provided the information.

### **Children Under Thirteen**
